### Project Description:

**1. Project Overview:** *Briefly describe your project. What are your goals?*

To commemorate Brookfield's 225th anniversary, a group of 5-10 Brookfield adults and high school students will research and create a piece of monumental public art under the guidance and leadership of Brookfield Craft Center artist-in-residence Peter Kirkiles. The sculpture will be permanently installed in the newly developed Four Corners District, celebrating the history of Brookfield's industries along the Still River. Once known as Iron Works Village, this portion of town was home to scissor, hat, button, clock and iron factories. Participants will create the piece using the Craft Center's equipped art studios and unveil the sculpture during Brookfield's 225th anniversary celebration. The goal of the project is to provide a research driven hands-on creative education experience to a group of Brookfield artists, and for the work of those artists to further educate residents and visitors about the town's industrial heritage.

**2. Community Impact:** *How will your project enhance learning within the Brookfield community?*

The 225th year of Brookfield is an opportune time to research and learn about the town's past, while also highlighting the town's vibrant present and future. The group of Brookfield residents performing the project will have an unparalleled experience learning from a celebrated sculptor and accomplished monumental art fabricator, collaborating and working on equal ground with residents of varying ages, interests and skills, and taking part in a permanent fixture in their own public space. During the project, school groups and the public will be welcome to observe the project in action with demonstrations of the artistic process. Field trips can be centered on local and industrial history, as well as art, creativity and problem-solving. This is also an opportunity for the Brookfield public to learn about contemporary American craft and Brookfield Craft Center, a non-profit art education establishment in town since 1954.

3. **Evaluation:** How will you know you have reached your desired objectives? What measurements will you use?

The project will meet our objectives by documenting: 1. the people of Brookfield as they engage in learning about the town's heritage through attending demonstrations at the site and other public settings such as the library; 2. how the work activates a public space in the new Four Corners District. We will measure this success by: A. a survey of participants, town officials and public visitors of their personal experience with the project; B. the number of participants in the building process; C. tracking the quantity of press coverage and social media interaction on the subject. We will document the impact and quality of the public monument with pictures of people smiling and taking pictures, people of varying ages dwelling in the space and interacting with the art, the ease of access and visibility, and townspeople referencing the monument in the public space with pride.

5. **Future Implications:** *How can your project lead to future community educational opportunities?*

This monument of public art produced by residents of Brookfield at a significant time of celebration in our town's history will affirm the community's past, present and future identity as a creative, vibrant town, and enhance the engaging environment of Brookfield's revitalized town center. This project will build community by forming strong relationships among creative teen through senior residents, and connecting residents and visitors to the heritage of the town. This project will initiate dialog about town history and industry, serving as a springboard for lesson plans and educational field trips. Just as Peter Busby's horse sculptures inspired us to create more public art in Brookfield, integrating art and history into our public spaces will spark future creative education initiatives in town.

6. **Project Budget:** *If awarded, how do you propose to utilize the funds*


The \$4000 requested will fulfill a requirement for 100% matching funds for an Arts Catalyze Placemaking grant through Connecticut Office of the Arts. If the state grant is also awarded, the \$8000 total budget will be utilized for expenses directly affecting the execution of the project: artist fees and sculpture materials, administrative expenses, project documentation, and publicity and printing expenses. ### **7. What prompted the idea for this proposal:**

The Craft Center is a member of the steering committee organized by the Brookfield Chamber of Commerce to plan the events of Brookfield's 225<sup>th</sup> anniversary. The development of this project was sparked by the first meeting of this committee at the Brookfield Public Library. Federal and state funding for the arts has made a recent shift to focusing on creative placemaking, which is defined as creating cities, towns and villages where people want to come to live, to work, to play and to learn. With the Four Corners revitalization project well underway, this is the perfect time for Brookfield to take an exciting creative education experience and parlay it into an engaging public space in the hub of town for generations to come.

Made by talented residents, the monuments will affirm this community's past, present and future identity as a creative, vibrant town, and enhance the engaging environment of Brookfield's revitalized town center.
